How to Apply for the Housing Choice Voucher Program Applicants must appear in person to complete an application at the CDA’s office located at 1228 Town Centre Drive in Eagan, Minnesota. Applications are available from 8 a.m. to 4 p.m. Monday through Friday. Applications are also available from 8 a.m. to 7 p.m. on the third Wednesday of the month to accommodate those who can not apply during regular business hours.

Applicants should bring a form of photo identification (such as a driver’s license or immigration card) and proof of a Dakota County preference. Social Security numbers must also be provided for every household member that will be listed on your application.

Examples of preference documentation include: a driver’s license, ID card or copy of a lease showing a Dakota County address, recent pay stubs for employment in Dakota County, or record of full-time enrollment at a Dakota County school.

Applicants not providing proof of a preference at the time of application will not be placed on the list. Only one application may be submitted per household. If more than one application for a household is received, all applications for that household will be discarded and will not be placed on the waiting list.
