# Website Redesign

## ADVANCING MINNESOTA'S OLMSTEAD PLAN

The Olmstead Plan housing goal states, "People with disabilities will choose where they live, with whom, and in what type of housing." In 2015 we completed the redesign of our website to advance Minnesota's Olmstead Plan. We made the following updates:

## ENHANCED ACCESSIBILITY FILTERS

Renters with disabilities can search for housing that meets their needs using these filters:

- No step approach to building & unit
- Automatic door entry
- Net clearance of 32" for all building/unit passageways
- Roll-in shower
- Grab bars in bathroom
- Easily operated handles on doors (levers/loops)
- Assisted or congregate living
- Emergency pull cord in bathroom
- Elevator
- Lowered kitchen countertops

## MOBILE FRIENDLY

Over 50% of visitors to the HousingLink website use a mobile phone or tablet. The website now works great on mobile devices!

## SAVE A SEARCH

Visitors can now save a search on our website! This makes it easier when they return to look for housing again. They can also receive notifications of new vacancies & waiting list openings by email or text message.

## SHARE LISTINGS

People searching for affordable housing can now share listings via email with friends, family, or clients they are helping.

## **CREATE AN ACCOUNT**

Visitors can now create an account on our website. This allows them to save a search, share listings, and more. Since we launched the site on September 20th, 2015, over 3,800 people have created an account!
