

St. Louis Park Bring It Home Waiting list St. Louis Park, MN

Online applications will be available: Monday, January 26, 2026 at 8 a.m. through Wednesday, January 28, 2026 at 4:30 p.m.

Applications will be accepted online only during this period at <https://housing.slpmn.us>. Translation is available in 60 different languages. **Applications will not be available in the Housing Authority (HA) offices, and fax or e-mail requests will not be accepted. The HA will not provide telephone assistance for applications.** Applicants needing a reasonable accommodation should submit a written request to the HA at 5005 Minnetonka Blvd, St. Louis Park, MN 55416. Computers for public use are available at public libraries and may be available at other community organizations.

The Bring It Home (BIH) Rental Assistance program is a new program funded through MN Housing to create rental assistance for low-income families across Minnesota. This is a tenant-based rental assistance program where tenants pay approximately 30% of their income towards their rent. The St. Louis Park BIH subsidy can only be used in St. Louis Park, Minnesota and cannot be transferred to another housing authority for assistance in a different city.

Households are eligible to apply for the St. Louis Park BIH program if they:

- Are a Minnesota resident;
- Have an annual income of up to 50% of the area median income (AMI) as determined by the United States Department of Housing and Urban Development (HUD), adjusted for family size;
- Pay more than 30% of the household's annual income on rent;
- Are not receiving federal tenant-based assistance under Section 8 of the United States Housing Act of 1937, as amended; and
- Are not currently in a unit receiving project-based assistance under Section 8 of the United States Housing Act of 1937, as amended

In order to qualify, the annual gross household income cannot exceed 50% AMI.

Additional preferences will be granted to households with incomes at or below 30% AMI.

Preference Eligibility

- Have a child or children aged 18 years or younger in the household
- Annual household income at or below 30% Area Median Income
- Residency preference: Live, work, hired to work, or attend K-12 school in St. Louis Park, MN
- Elderly, near-elderly (age 50 or older) or disabled preference
- Veteran’s or service person preference: Veteran or member of the armed services, widow/widower of veteran
- Indicate intent to use the subsidy at your current residence in St. Louis Park

Applicants can only be on **one** application. Applications must meet income and eligibility requirements. Applicants will be placed on the waiting list according to the preference(s) for which they qualify, and the date and time randomly applied to the applications.

If selected for the program, applicants will be notified in order of their placement on the waiting list to be screened for eligibility. Applicants do not need to be current St. Louis Park residents to apply, but the St. Louis Park Bring It Home subsidy can only be used in St. Louis Park, Minnesota.
